The Public Company of an Industrial and Commercial nature, National Frequencies Agency is launching a notice of an Open National and International Invitation to tender with minimum capacity requirements for the acquisition of an IT solution to support the activities of the National Frequencies Agency

This Invitation to Tender is intended exclusively for companies specialized in the edition of IT solutions dedicated to spectrum planning, management and monitoring, satisfying the following three conditions:

- Be a sector member of the ITU-R (this requirement can be checked on the website: [www.itu.int](http://www.itu.int));
- And having developed an integrated IT solution for automated spectrum management;
- And having at least ten years of experience in the edition of IT solutions dedicated to spectrum planning, management and monitoring;
- And having deployed, during the last five years, this IT solution, at least, for two ITU member administrations.

The Tender Specifications document can be withdrawn by the interested bidders, directly or by duly mandated representatives, at the General Directorate of the National Frequencies Agency, whose headquarters are located at 04 Boulevard Krim Belkacem Algiers Algeria, upon payment of a non-refundable fee of ten thousand dinars (10,000.00 DA) which have to be transferred to the following postal current account “**CCP n° 7882929 clé 19**” opened in the name of the Agence Nationale des Fréquences.

A bid bond greater than one percent (1%) of the maximum amount of the tender (when the tender is greater than 300,000,000.00 DA) must be presented by the tenderer in his technical tender. Bidders must submit their tenders accompanied by documents listed in Article 18 of the

tender specifications. Each tenderer must submit his tender in one original and two (02) copies, respectively marked as "original", "copy 1" and "copy 2".

The application file, the technical tender and the financial tender, shall be placed in separate envelopes.

The three envelopes shall then be enclosed in one single anonymous envelope with the following mention:

Tenderers must submit their tenders accompanied by the documents listed in Article 18 of the tender specifications. Each tenderer must submit his tenders in one original, two (02) copies, marked "original", "copy 1" and "copy 2" respectively and in electronic format. The following files should be placed in separate envelopes:

- The application file including;
- The technical offer;
- The financial offer.

Tenders must be presented in separate envelope with the mention "to be opened only by the committee for opening bids and evaluating Tenders".

Tenders must be remitted to the National Frequencies Agency at the above address, during the last day of the tender preparation period between **eight and twelve o'clock (8.00 -12.00 pm)**, **time limit**. No tender will be accepted beyond the closing date and time of submission indicated above.

The opening of folds in public session, by the " the folds opening and tenders evaluation commission" of the National Frequencies Agency, will take place on the same day as the submission of the aforementioned tenders at **fourteen o'clock (2:00 pm)**, in the presence of the bidders or their representatives.

The validity of the tenders is fixed at **90 days** plus the duration of preparation of the above-mentioned tenders
